He is the Founding Trustee of the African Institute for Leaders and Leadership (ALL) and founding Chairman of the Association of the Citizens Against Corruption (ACAC). In 2001, he was appointed by Honourable, the Attorney General to serve in the National Committee on Implementation of International Humanitarian Law. An articulate lawyer, who holds a PhD in Laws of the sea from the University of Ghent in Belgium. He is also a firm Pan-Africanist and has delivered a number of powerful, public speeches about African solutions to African problems.
